1. The Authority of Scripture

Authority is the Bible's right to command belief and/or action, because of its inspiration, canonicity, inerrancy, and infallibility.



"We Christians are forbidden to introduce anything on our own authority, or to choose what someone else introduces on his own authority. Our authorities are the Lord's apostles, and they in their turn choose to introduce nothing on their own authority. They faithfully passed on to the nations, the teaching which they had received from Christ."

-Tertullian

2. The Sufficiency of Scripture

Scripture is sufficient in that it is the only inspired, inerrant, and therefore final authority for Christians for faith and godliness, with all other authorities being subservient to Scripture.

2 Timothy 3:16-17

All Scripture is breathed out by God and profitable for teaching, for reproof, for correction, and for training in righteousness, that the man of God may be complete, equipped for every good work.

Westminster Confession of 1646

"The whole counsel of God concerning all things necessary for His own glory, man's salvation, faith and life, is either expressly set down in Scripture, or by good and necessary consequence may be deduced from Scripture: unto which nothing at any time j to be added, whether by new revelations the Spirit, or traditions of men."

According to Barna Research:

- -25% make their moral and ethical choices based on the Bible.
- -20% base their choices on whatever "feels right."
- -10% make choices based on whatever will minimize conflict.
- -8% rely on what parents taught them in terms of values and principles.

According to Barna Research:

-Only 14% of born-again adults, (or 1 out of every 7), rely on the Bible as their moral compass, and believe that moral truth is absolute!





4. The Infallibility of Scripture

Infallibility is very close to inerrancy in that it's also without error. But in addition to having been properly recorded, it also means that the content of the Bible won't lead us into error—that it's true and trustworthy in all matters it addresses. It wasn't just transmitted accurately, but its message is accurate objectively, historically, scientifically, and morally.








Number of Manuscript Copies


